Please read carefully and INITIAL

____ I have never been convicted of any animal related crime or domestic violence.

____ I am at least 18 years of age.

____ I understand that the handling of animals and other foster activities may place me in harmful situations and could result in injury to myself or my personal property. On behalf of myself, my heirs, personal representatives and assigns, I hereby release, discharge, indemnify, and hold harmless **Michele's Rescue and/or its representatives** from any and all claims, causes or actions and demands of any nature, whether known or unknown, arising out of or in connection with my fostering activities.

____ I understand if I become a **Michele's Rescue** foster, I will comply with the all the rules, policies, and communications directed to fosters. I understand that I will be free to leave my foster position giving at least 10 (ten) days' notice, with or without cause, and I also understand and agree that **Michele's Rescue and/or its representatives** may also terminate my foster duties at any time or without cause, at which point I will return any and all equipment assigned to me for fostering duties.

____ In the event that I do not return any and all equipment provided to me by **Michele's Rescue**, I understand I will be charged a fee of \$100 (one hundred dollars).

____ In case of loss or injury due to neglect, or theft of foster animal in my care, I am fully responsible for the adoption fee and/or medical bills, as well as any court or attorney fees incurred.

____ I grant **Michele's Rescue and/or its representatives** the right to use my name, as well as any minors listed below that I am signing on behalf of, print, images, video and/or electronic media for marketing, public relations, and/or educational purposes. **Michele's Rescue and/or its representatives** retains all rights to use, publish, or distribute said names or images and has the right to do so without seeking further permission from me or providing me or said minors any royalties.
